# **Terms and Conditions**

#### **ENTRANT DECLARATION**

I pledge to raise a minimum of \$8,500, which is separate to the entry fee of \$385 (inc GST) paid to Variety Queensland in order to take part in the 2018 Variety Bash.

I will endeavour to make payments/fundraising deposits to meet the minimum \$8,885 contribution as per the following:

\$385 (inc GST) with this application for entry - note: fundraising monies cannot be used to cover entry fees and provisions levies

2000 donation/fundraising on or before 12th January, 2018

2000 donation/fundraising on or before 30th March, 2018

\$2250 donation/fundraising on or before 25th May, 2018

 $2250 \, \mathrm{donation/fundraising} \, \mathrm{on} \, \mathrm{or} \, \mathrm{before} \, 27 \mathrm{th} \, \mathrm{July}, 2018$ 

In addition, I agree to pay a per person provisions levy which will include some meals, entertainment and merchandise. I understand the provisions levy fee will be advised closer to the event date.

I understand that acceptance of entries in the 2018 Variety Bash is at the absolute discretion of Variety Queensland Inc. and that receipt of this Application Form does not guarantee a place on the Variety Bash. I also understand that my team and I enter entirely at our own risk and that we will each sign an Indemnity Form prior to the event. I give permission to receive marketing and promotional material/information from Variety Queensland as well as permission to include any photography/film footage of myself, our team and vehicle.

I understand and agree to abide by the Variety Bash Code of Conduct & Event Rules and Regulations.

I understand that all entrants must be over the Age of 18 years at the start of the Variety Bash on 22nd August, 2018.

# VARIETY BASH CODE OF CONDUCT & EVENT RULES AND REGULATIONS

The Code of Conduct has been set by Variety – the Children's Charity of TENT 76 to ensure the safety of all participants and protect the reputation of the Variety Bash and Variety. It contains simple common sense rules and is viewed most seriously.

It is up to each participant / team to police the conduct of other team members. Anyone not adhering to the code may be forced to withdraw from the Variety Bash Event and may not be invited to participate in future Variety events. As a Variety Bash entrant you are not exempt from state laws or road rules, and anyone caught breaking the law may be prosecuted.

The Variety Bash Rules and Regulations are those made by the Variety office at any time. All entrants agree to abide by these rules upon registration into the Variety Bash.

The Rules and Regulations may be altered and amended at any time and as seen fit by Variety. Any decision handed down by Variety will be final with no discussion entered into. During the Variety Bash event if any dispute arises as to the interpretation of any of the rules, the Variety Bash Event Management decision will be final.

## TAX DEDUCTIBILITY

Monies donated to Variety Queensland Inc. by individuals are generally tax deductible, provided they qualify as an unfettered donation, that is, the donor can prove that they have received no value in return for the donation. Similarly, an unfettered donation by a company not being associated with an advertising or promotional activity would normally be tax deductible.

Sponsors and entrants should accordingly be aware that the following are <u>PERSONAL ENTRANT</u> <u>EXPENSES</u> and are not to be accrued through sponsors as donations as they are not deductible as donations and are subject to GST.

- (i) Any entry fee;
- (ii) Meal costs;
- (iii) Accommodation costs;
- (iv) Vehicle purchase preparation, maintenance and running costs;
- (v) Merchandise purchases;
- (vi) Travel costs;
- (vii) Car cartage costs.
- (viii) Auction Item Purchases

Depending on the ownership and normal use of the vehicle, some or all of the above costs may be claimable.

These comments are to be taken as guidelines only. Variety Queensland Inc. is not a tax consultant and therefore assumes no liability for actions taken as a result of these guidelines. In any instances where an entrant or a sponsor is uncertain of tax implications of their involvement, they should consult their own accountant or tax adviser.
